

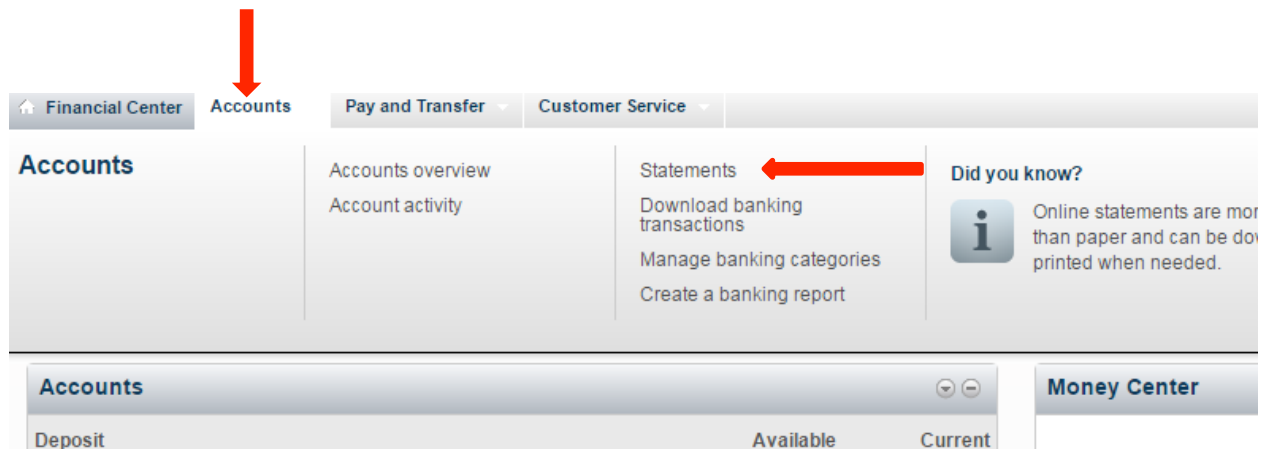

The instructions below will help guide you through the e-statement enrollment process. If you are unable to successfully enroll and get the confirmation message, please call the Bank at 763-972-3385.

1.) Step one: Sign into your online banking account.

Once you sign into your online banking account, click the Accounts tab on the top menu bar and you will see the option to click Statements.



2.) Step two: Click on statements.

- 3.) **Step Three:** Under the statement link you will need to click on the Statement Service Agreement and Disclosure hyperlink. Once you have read and agreed to the terms, exit out of the Statement Service Agreement and click on the check box next to the disclosure and click Submit.

Add Online Statements

What is an online statement?
Online statements are electronic versions of the statements you receive in the mail. Online access means that you can view your statements at any time, from any location.

What are the benefits of online statements?

- Save time. Online statements are delivered faster than those sent through the mail. An e-mail is sent to you when a new statement is available.
- Save space. Online statements can be saved to your computer and printed only when needed. Gone are the files, drawers, and boxes filled with bank statements!
- Keep your personal information secure. Secure Sign On helps us protect your valuable information including online statements.


What types of accounts are eligible for online statements?
Checking accounts, savings accounts, certificates of deposit, money market accounts, loans, and credit cards can receive online statements.

If you are ready to start receiving online documents, we ask that you read our Service Agreement and Disclosure and select the following box to indicate that you agree to the terms of use.
